

平成30年度地下水の水質測定結果について

1 内 容

水質汚濁防止法第15条の規定により、地下水の水質の状況を把握するため、岡山市及び倉敷市と協力して、測定を実施した。

(1) 対象項目

地下水の水質汚濁に係る環境基準が定められている環境基準項目(カドミウム等28項目)及び要監視項目(クロロホルム等24項目)

(2) 測定方法

表5のとおり、県内31地点において概況調査を行うとともに、過去に汚染が確認された8地点で継続監視調査を行った。測定項目及び頻度については、表6のとおりである。

2 結 果

(1) 概況調査

31地点のうち、3地点(西粟倉村影石:ふっ素、岡山市北区撫川:ふっ素、倉敷市鳥羽:ふっ素)で環境基準を超過した。

(2) 継続監視調査

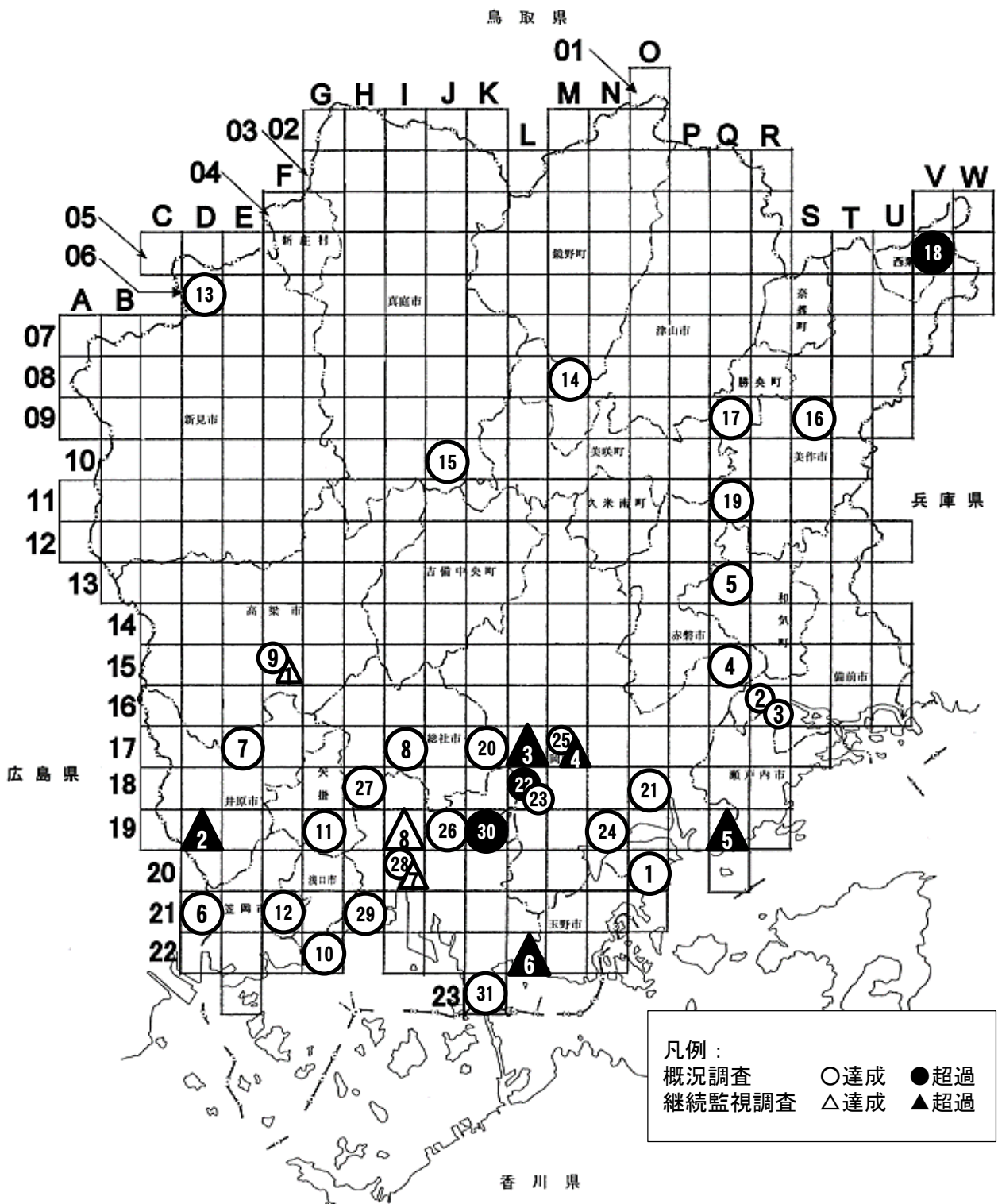
8地点のうち5地点で、依然として調査対象物質が環境基準を超過していた。

3 今後の対応

概況調査で環境基準を超過した地点については、原因究明を図るための周辺調査を実施し、その結果に応じて継続監視調査に移行する。

継続監視調査を行った8地点のうち、4地点(岡山市北区今岡、岡山市北区首部、岡山市東区西片岡、倉敷市連島中央)は、飲用指導済みであることや施肥・自然由来と判断したこと、数値に大きな変化が見られないか、又は基準未満となったことなどから調査を終了し、他の4地点は引き続き調査を継続する。
